**CONTRACT TERMS:**

**BOOKINGS:** To secure a date, a signed contract is required with a deposit due at the time of signing. The deposit will be calculated based on the number of individuals receiving services. The deposit is non-refundable and non-transferable. The deposit is deducted from the final balance due. Please be advised, dates and scheduled makeup times will only be reserved when a signed contract and deposit are received. **Cash, Venmo or PayPal will be accepted for deposits.**

- 1-4 individuals receiving services: \$50 deposit required
- 5-8 individuals receiving services: \$75 deposit required
- 9+ individuals receiving services: \$100 deposit required

**BOOKING TIMES:** A start time and end time will be determined and approved by the client. The Makeup Artist(s) will arrive 15 minutes prior to scheduled call time in order to set up. Each makeup application requires a certain length of time to be finished and is not to exceed time limit. When reserving your date, book accordingly. Any additional makeup needs outside contract will only be performed at the discretion of the makeup artist.

**PRE-WEDDING DAY SERVICES:** A makeup consultation is strongly recommended for all bridal clients. It is designed for each client to connect with the artist and to determine the desired look for the day. Please allow up to 1.5 hours for Makeup Consultations. I also provide makeup services for engagement pictures, bridal shower, and/or other wedding related events. Because these are additional services, they have separate fees and are due when services are rendered. If the client needs to make changes to any of these services, please call at least (5) days in advance to reschedule.

**SERVICE LOCATION REQUIREMENTS:** All wedding day services will be provided on location and at the discretion of the client, but there are certain requirements the makeup artist needs to complete the makeup. A set up table/work area, chairs, and outlet need to be made available for the makeup artist at said location. Makeup artist will provide lighting.

**LIABILITY:** All brushes and makeup products are kept sanitary and are sanitized regularly. Any skin condition should be reported by the client to the makeup artist prior to application. Client agrees to release the makeup artist from liability for any skin complications due allergic reaction.

**PARKING FEES:** Where valet or parking fees may be incurred, the client will handle the amount the day services are provided.

**PAYMENT:** The final balance is due on the day of the wedding upon departure of the Makeup Artist(s). The person responsible for the entire balance of payment is the person who has signed the booking contract. Any cancellation in services after this contract has been signed must be paid in full (eg. Bridemaid(s) deciding against application after this contract is signed). All cancellations must be made in written form by email.

**CANCELLATION POLICY:** Should a client cancel the booked event or any service on a contract, the deposit will not be refunded or transferred. If the makeup artist cancels at any time or unable to perform her duties for any reason the deposit paid will be fully refunded. If the client cancels 30 days prior to the service date 50% of the total rate quoted will be charged. If the client cancels less than 30 days prior to the service date, the client will then be charged 100% of the total rate quoted.

**SOCIAL MEDIA & WEBSITE:** Photos taken at the trial or your professional photos may be used as examples of my work for future clients to view. Your photographer will receive proper credit for their work. You agree to me using these photos, as well as give consent to using your professional photos on my website and social media. I will email you to request these photos and will also reach out to your photographer.
